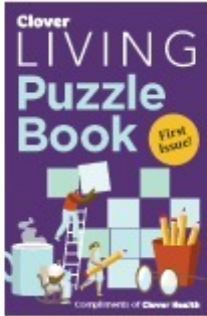
Clover's blackout period is from October 1 to December 31. Agents may not move or transfer uplines during this period.

Active SEPs:

Texas: A renewed state of emergency was declared for Texas on 8/5/22, allowing for an SEP effective through 10/31/22. This SEP exists for individuals in all of our Texas service areas, with the exception of El Paso.

Mississippi: A federal disaster has been declared for Hinds county in Mississippi on 8/30/22, allowing for an SEP effective through 10/31/22.

Georgia: A federal disaster has been declared for Georgia on 9/27/22, allowing for an SEP effective through 11/30/22.

South Carolina: A federal disaster has been declared for South Carolina on 9/29/22, allowing for an SEP effective through 11/30/22.

These SEPs exists for individuals in our service areas who were affected by a disaster or other emergency declared by a federal, state or local government entity who were unable to, and did not, make an election during another valid election period.
